9. The institution shall maintain the record and books of accounts, which shall be audited by Chartered Accountant or any other authority on annual basis and shall be open for inspection by the university.
10. The institution shall furnish requisite returns as prescribed by the University for ensuring maintenance of standards.
11. The institution shall be visited by an officer or a committee of the university to inspect and review the progress of the institution in fulfilling norms and procedures as laid down by the AICTE/University.
12. The institution shall not charge any Capitation fee or donation for admission or other higher charges from students or their parents in any form.
13. The institution will have an independent building as per norms of the University with a separate approach.
14. This order shall stand cancelled in case the college fails to deposit Affiliation fee (unless specifically exempted) by the due date.
15. The affiliation is subject to strict compliance of Anti-Ragging regulations.
